ORDER OF THE SUPREME COURT OF TEXAS

IN THE MATTER OF JEFFREY HARBIN CONNER

The Court has reviewed the Motion for Acceptance of Resignation as Attorney and Counselor at Law of JEFFREY HARBIN CONNER, State Bar No. 04698555 and the Response of the Chief Disciplinary Counsel for the Commission for Lawyer Discipline. The Court concludes each meets the requirements of Part X of the Texas Rules of Disciplinary Procedure. In the absence of a request by JEFFREY HARBIN CONNER to withdraw his motion, the Court deems the professional misconduct detailed in the Response of Chief Disciplinary Counsel conclusively established for all purposes. The Court further concludes that acceptance of JEFFREY HARBIN CONNER'S resignation is in the best interest of the public and the profession.

IT IS ORDERED that the law license of JEFFREY HARBIN CONNER of Lubbock, Texas, State Bar Card Number 04698555, is canceled and his name be dropped and deleted from the list of persons licensed to practice law in Texas.

IT IS FURTHER ORDERED that JEFFREY HARBIN CONNER immediately surrender his State Bar Card and Texas law license to the Clerk of the Supreme Court of Texas or file with the Court an affidavit stating the cause of his inability to do so.

and prohibited from practicing law in the State of Texas, holding himself out as an attorney at law, performing legal services for others, giving legal advise to others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative body (whether state, county, municipal, or

other), or holding himself out to others or using his name in any manner in conjunction with the words "Attorney at Law," "Counselor at Law," "Lawyer," or "Attorney."

IT IS FURTHER ORDERED that JEFFREY HARBIN CONNER shall immediately notify in writing each of his current clients of his resignation. In addition to such notification, JEFFREY HARBIN CONNER is **ORDERED** to return any files, papers, unearned monies and other property in his possession belonging to any client or former client to the respective client or former client or to another attorney at the client's or former client's request. JEFFREY HARBIN CONNER is **ORDERED** shall file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, Post Office Box 12487, Austin, Texas 78711-2487, within thirty (30) days of the date of this Order an affidavit stating that all current clients have been notified of his resignation and that all files, papers, monies, and other property belonging to all clients and former clients have been returned.

IT IS FURTHER ORDERED that JEFFREY HARBIN CONNER shall, within thirty (30) days after the date of this Order, notify in writing each justice of the peace, judge, magistrate, and chief justice of each court in which JEFFREY HARBIN CONNER has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s) JEFFREY HARBIN CONNER is representing in court. JEFFREY HARBIN CONNER is ORDERED to file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, Post Office Box 12487, Austin, Texas 78711-2487, within thirty (30) days of the date of this Order an affidavit stating that he has notified in writing each justice of the peace, judge, magistrate, and chief justice of each court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s) he is representing in Court.

IT IS FURTHER ORDERED that JEFFREY HARBIN CONNER shall make payment of restitution as follows: David Garza in the amount of \$8,400.00 (USD) and Robert Elliott in the amount of \$2,500.00 (USD).

Payment of the restitution is a condition precedent for the reinstatement of JEFFREY HARBIN CONNER. All payments shall be made by certified or cashier's check and delivered to the State Bar of Texas, 6300 La Calma, Suite 300, Austin, Texas 78752.
