2020 GAFEDP Annual Report

On September 1, 2019, the Office of Court Administration implemented the Guardianship Abuse, Fraud, and Exploitation Deterrence Program (GAFEDP). As we look back on this past year, it is clear that 2020 was challenging for everyone and their families. During the implementation of the GAFEDP, the Office of Court Administration (OCA) managed several crises while ensuring Texas courts remained operational. Through continual communication from our OCA Administrative Director, David Slayton, and the use of "Zoom" video proceedings along with coordination with state and local health authorities, we were able to disseminate information about the COVID-19 Pandemic to ensure court and public health and safety.

In mid-March, the OCA asked all employees to work remotely, away from the office. The new remote environment enabled our team to remain fully operational and provide the same services and resources our customers are accustomed to. During the OCA pandemic response and with our team adjusting to working remotely, the OCA was struck by an unfortunate ransomware attack that crippled our team's use of computer technology systems for several months. As the OCA Information Services team worked to repair the ransomware attack and systems were brought back online, our team continued to operate towards its mission without the full use of computer hardware and software.

Throughout our first year of the GAFEDP implementation statewide, we have continued to coordinate the ongoing management of the program, conduct training, develop program procedures, develop financial workbooks and audit procedures, and continued data collection, all while working in numerous counties and in various stages. This report outlines Texas guardianship reforms and all aspects of the implementation of the GAFEDP and its mission to "protect our most vulnerable citizens and their assets."

Program Overview

Since November 1, 2015, the OCA began managing the Guardianship Compliance Project (GCP) to provide additional resources to courts handling guardianship cases. On September 1, 2019, the OCA implemented the GAFEDP to provide assistance to the courts relating to guardianship matters pursuant to <u>SB31</u> & <u>HB 1286</u> (Zaffirini/Smithee). Our team of guardianship compliance specialists assist in reviewing guardianship cases to identify reporting deficiencies by guardians, auditing annual accountings, reporting their findings back to the judge, and reporting to the courts any concerns of potential abuse, fraud, or financial exploitation being committed against a ward under guardianship.

The program is offered at no expense to counties throughout the state. Courts throughout the state are required to participate in the program if selected and may also request program participation.

Additionally, the OCA director may notify the Judicial Conduct Commission of any concerns involving judges who fail to act upon concerns raised by compliance specialists. To date no judges have been referred to the Judicial Conduct Commission.



Compliance Monitoring and Financial Reviews

Guardians' annual reports of well-being and financial annual accounts will be monitored for compliance for individual counties and reports will be reviewed for compliance and appropriateness and reported back to the court. Qualifying annual accounts will be audited to ensure data submitted is complete and accurate. Monitoring and auditing will serve as a deterrence against theft and fraud.

The team continues to develop tools and protocols for the completion of financial audits. A financial audit workbook has been developed and expanded to allow for completion of financial audits. The staff has participated in the process of testing and making recommendations for changes. The result is the first financial tool of its kind in Texas to be used for auditing guardians' annual accountings. Once completed, the program will begin work in creating its financial audit database to assist in compiling relevant data for all audits completed.

Follow-up Compliance Reviews

Guardianship Compliance Specialists will, upon completion of initial case file reviews for compliance, complete 90-day follow-up reviews in individual counties to ensure both the guardian and the courts are taking measures to ensure compliance and address guardianships that need immediate attention due to possible well-being, abuse, fraud, or exploitation. Courts with less than desirable outcomes will then be reviewed for referral to the Judicial Conduct Commission.

Team Member Training and Development

The GAFEDP team is currently comprised of sixteen of the total twenty-three members appropriated. There is currently a hiring pause in place for the additional positions due to budget considerations. Soon, we hope to continue hiring our team to fill all vacancies once the pandemic subsides to be able to provide these valuable services to courts throughout the state.

All guardianship auditor team responsibilities have been expanded from the original Guardianship Compliance Project to the GAFEDP and have been formalized. New data-collection strategies have been implemented and the creation of a new financial audit workbook tool is almost complete. The program has developed and continues to expand the only known comprehensive procedures manual for conducting financial audits in the entire state.

The program released its first training series this fall which consisted of six virtual one-hour training sessions with program specific topics. The sessions are interactive and are recorded and made available to the staff for future reference and for future hires. In addition, dozens of in-house recorded training sessions are currently available to staff for their development.

Guardianship Online Reporting System Development

The Texas Guardianship Online Reporting System is being developed for guardians to file automated annual reports, annual accountings and other documents in guardianship cases. The system will provide a method to notify guardians when their reports are due as well as notify courts when required reports are delinquent. The system will also be used to assist the GAFEDP in reviewing annual reports and conducting financial audits of annual accounts.

The system will assist guardians throughout the state immensely by simplifying the process for filing reports by providing a guided process for report completion. It will also integrate with individual courts through eFile Texas. We are currently finalizing the details of a pilot project in both Cameron and Montgomery Counties.



Examples of Case Summaries Reported to the Courts



Per Adult Protective Service report, Ward passed away after multiple seizures due to improper medical care from the guardian. Co-Guardian currently under investigation for Ward's death and another unrelated offense.



Guardian's annual reports indicate she has not visited Ward in 15 years while living at a State Supported Living Center. The Court is approving the reports.




Ward expressed being emotionally abused and in need of dental work on several occasions in the past several court visits. Unable to contact guardian. No additional action has been taken by the court.





Guardian is allowing Ward to live with previous guardian after Order removed guardian in 2006. Court records indicate previous guardian has criminal convictions including but not limited to possession of controlled substance.

Ward married while under guardianship despite not having right to marry. The current guardian is the ward's spouse, and they have 6 children.



Guardianship of Estate closed without appointment of Ad Litem for the Ward. Estate valued at **\$1,977,915.23** in mostly liquid assets 04/29/2020. The estate was inappropriately closed due to a previously executed Power of Atty- which became void at establishment of the guardianship.

Guardian withdrawing funds and writing checks from guardianship account for personal expenses.



Required Certificate of Medical Exam not signed by a licensed physician.



Ward has increasing medical concerns and guardian is refusing to obtain medical care opting for "home remedies" instead.



Ward currently in the care of previously removed guardian despite guardian's removal due to neglect and exploitation. (Ward's Sister) Current program guardian has failed to remove the Ward from her care.
