21-0513 SIBEL ONASIS FERRER v. MADALENA ELIZABETH ALMANZA, ISABELLA P. ALMANZA, AND ALBERT BOONE ALMANZA; from Travis County; 7th Court of Appeals District (07-20-00300-CV, 647 SW3d 726, 03-16-21)

The Court affirms the court of appeals' judgment.

Justice Huddle delivered the opinion of the Court, in which Chief Justice Hecht, Justice Boyd, Justice Devine, Justice Blacklock, Justice Bland, and Justice Young joined.
